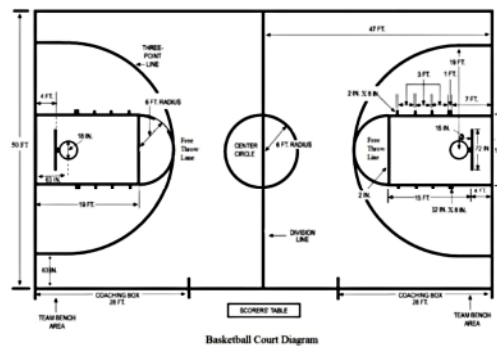

Official guidelines for participating teams:

1. Incomplete forms/Officials & Players photos not affixed to the form will be rejected (Photocopy photographs are not accepted).
2. The registered name should be the same as shown in the identity card.
3. Every team must prepare at least 2 sets of basketball jerseys – **dark coloured** jerseys and **light-coloured** jerseys every game.
4. Jersey numbers should start from 0-99.
5. All players should be under the sponsorship of the company for at least 3 months above.
6. Sister companies are allowed to form a team with the parent company.
7. Each team is allowed to have **three import** players with valid sponsorship/working permit of any other company for at least 3 months and above.
8. Each company is only allowed to send maximum of 2 teams (male players only).
9. Players are not allowed to conduct illegal contact on the court, any players caught on such action will be banned in every Sukan Ria Antara Syarikat in the coming future.
10. All teams should wear complete jersey during the tournament.
11. It is compulsory for all team managers to attend Team Manager meeting. Please visit www.sukanriabrunei.com for updates on Team Manager meeting.



General Game Rules:

SCORING:

- **2 point field goal** – a shot made from anywhere during play inside the 3 points arc.
- **3 point field goal** – a shot made from anywhere outside the 3 points arc.
- **Free throw** – 1 point is awarded to an unguarded shot taken from behind free throw line while the clock is stopped.

FOULS: Results in one or more free throws awarded to the opposing team

- **Blocking** – impeding the progress of an opponent by extending one or both arms horizontally or getting in the path of a moving player.
- **Charging** – running into a stationary player while you are moving with the ball.
- **Hacking** – the player hits the arm or hand of the person holding the ball.
- **Holding** – the player holds the person with or without the ball.

Violations: Results in a change of possession with the team in bouncing the ball at the side line opposite where infringement took place.

- **Travelling** – moving illegally with the ball.
- **Three seconds** – an offensive player remains in the key (free throw lane – the area under the basket) for more than 3 seconds.
- **Double dribble** – a player dribbles the ball both hands at the same time or they stop and then start dribbling again.
